1. Saib daim ntawv [Pre-Licensing Application Checklist \(PDF\)](#). Daim ntawv no yuav pab koj npaj ua ntej los sau daim ntawv thov rau daim ntawv tso cai ib ntus thaum nws npaj txhij hauv qhov cuab yeej online. Daim ntawv no **tsis yog qhov yuav tsum tau ua**; nws **tsis yog daim ntawv thov** rau daim ntawv tso cai ib ntus. Nws [faib rau cov chaw EIDBI uas twb sau npe lawm thaum Lub Kaum Ob Hlis](#).

2. Sau thiab npaj cov ntaub ntawv hauv qab no:

- Enrollment record ID — Nrhiav tau cov ntaub ntawv no hauv Minnesota Provider Screening and Enrollment (MPSE) portal los ntawm kev nkag mus rau koj tus account MN-ITS.
- Federal Employee Identification Number (FEIN)
- Provider identifier — Ib qho National Provider Identifier (NPI) los sis Unique Minnesota Provider Identifier (UMPI). Nrhiav tau cov ntaub ntawv no hauv MPSE portal los sis hauv tsab ntawv Welcome Letter uas Minnesota Department of Human Services (DHS) tau xa rau koj thaum Minnesota Health Care Programs (MHCP) pom zoo koj daim ntawv sau npe thawj zaug.

Koj yuav tsum muaj cov ntaub ntawv no thiaj li “claim” (los sis nkag mus siv) tau koj daim ntawv tso cai ib ntus hauv Provider Hub thaum nws npaj txhij. Tsuas yog cov chaw EIDBI uas twb sau npe lawm xwb thiaj li muaj tso cai los sau daim ntawv thov no.

Lub koom haum EIDBI yuav tsum xaiv ib tug neeg uas yog tus tswj hwm (controlling individual) los ua Tus Neeg Muaj Cai Tag Nrho (raws li tau txhais nyob rau [hauv Minnesota Statutes, nge 245A.02, subdivision 3b](#)). Tus Neeg Muaj Cai Tag Nrho yog tus neeg uas muaj lub luag hauj lwm los sib txuas lus nrog Minnesota Department of Human Services (DHS) Licensing. Nrhiav ntaub ntawv ntiv txog txoj hauj lwm no nyob rau nplooj ntawv thib ob ntawm [Pre-Licensing Application Checklist \(PDF\)](#).

4. Tus Neeg Muaj Cai Tag Nrho (Authorized Agent): Ua kom tiav [Daim Ntawv Pom Zoo Ntawm Tus Thov, Kev Lees Paub, thiab Kev Tshuaj Xyuas \(Applicant Agreement, Acknowledgement and Verification Form\)](#) nrog ib tug notary public. Tus Neeg Muaj Cai Tag Nrho yuav tsum upload daim ntawv uas twb kos npe thiab muaj notary lawm ua ib feem ntawm daim ntawv thov.

5. Saib [EIDBI Cov Lus Uas Nquag Nug \(FAQs\)](#). Lub webpage no qhia ntiv txog txheej txheem ntawm kev tso cai.

Lub Ib Hlis 2026
