1. Xyuas daim ntawv [Pre-Licensing Application Checklist \(PDF\)](#). Daim ntawv no yuav pab koj npaj kom ua tiav daim ntawv thov rau daim ntawv tso cai ib ntus. Daim ntawv no tsis yog tias **yuav tsum tau muaj**; nws **tsis yog daim ntawv thov** rau daim ntawv tso cai ib ntus. Nws tau [muab qhia rau cov chaw EIDBI uas twb sau npe nyob rau thaum lub Kaum Ob Hlis](#).

2. Sau ua ke cov ntaub ntawv nram no:

- Enrollment record ID — Nrhiav tau cov ntaub ntawv no hauv Minnesota Provider Screening and Enrollment (MPSE) portal los ntawm kev nkag mus rau koj tus account MN-ITS.
- Federal Employee Identification Number (FEIN)
- Provider identifier — Ib qho National Provider Identifier (NPI) los sis Unique Minnesota Provider Identifier (UMPI). Nrhiav tau cov ntaub ntawv no hauv MPSE portal los sis hauv tsab ntawv Welcome Letter uas Minnesota Department of Human Services (DHS) tau xa rau koj thaum Minnesota Health Care Programs (MHCP) pom zoo koj daim ntawv sau npe thawj zaug.

Tus Neeg Muaj Cai Tag Nrho yuav tsum upload daim ntawv uas twb kos npe thiab muaj notary lawm ua ib feem ntawm daim ntawv thov.
