Provider Hub Yog Dab Tsi

Provider Hub yog ib qho cuab yeej siv hauv online los thov cov ntawv tso cai, nyiaj pab, thiab lwm yam kev pabcuam ntawm tsoom hww.

Niaj hnub no, cov chaw uas muaj ntaub ntawv pov thawj thiab muaj kev tso cai zov menyuam siv lub Provider Hub no los ua tej:

- Ntaub ntawv Tso Cai/Ntaub Ntawv Pov Thawj

- Kev koom nrog qhov kev pabcuam Great Start Compensation Support Payment Program

Thaum Koj Yuav Tsum Siv Provider Hub Rau KevTso Cai

Peb twb tau tshaj tawm yav tas los lawm tias kev tso cai rau kev zov menyuam hauv tsev yuav npaj qhib nyob rau hauv Provider Hub thaum lub caij ntuj sov xyoo 2025. Tam si no **peb tab tom hloov kho lub sijhawm ntawd kom koj muaj kev siv tau zoo rau koj**. Peb tseem tab tom txiav txim siab txog hnuv twg mam li yuav qhib tiag.

Peb nkag siab tias kev hloov sijhawm no tej zaum yuav tsim tau kev txhawj xeeb thiab tsim kev tsis txaus siab tiamsis peb ua nej tsaug kawg li uas nej tseem muaj lub siab ntev tos. Ntawm no yog cov ntaub ntawv uas peb twb muaj tam sim no lawm:

Kev Sim

Peb yuav pib sim qhov kev tso cai rau kev zov menyuam hauv tsev hauv lub Provider Hub nrog cov cheeb tsam hauv qab no ua ntej: **Becker, Cass, Crow Wing, Douglas, Hubbard, Morrison, Stevens, Todd thiab Wadena**. Cov cheeb tsam no ua haujlwm koom tes nrog [Sourcewell](#) los saib xyuas kev tso cai rau kev zov menyuam hauv tsev.

Cov chaw uas zov menyuam hauv tsev nyob hauv cov cheeb tsam no yuav tau txais cov ntawv ceeb toom txog hnuv uas peb yuav pib kev sim no **tsawg kawg 60 hnuv ua ntej**. Qhov kev sim no yuav siv sijhawm li ib lub hlis.

Kev Qhib Hauv Cheeb Tsam

Tom qab tau sim tiav lawm, Provider Hub yuav pib qhib rau [cov cheeb tsam ib qho zui zus](#). Peb yuav qhia txog kev npaj qhib raws cheeb tsam hauv peb cov ntawv tshaj tawm yuav los tom ntej no.

Peb yuav xa ntaub ntawv ceeb toom ua ntej rau koj thiab lwm qhov chaws zov menyuam hauv tsev ntawm koj cheeb tsam txog kev yuav pib siv lub Provider Hub no los thov cov ntaub ntawv tso cai no rau thaum twg.

Peb yuav npaj ib lub rooj cob qhia uas qhia rau sawv daws tuaj koom tim ntsej tim muag hauv koj cheeb tsam ze rau lub sijhawm uas koj yuav tsum pib siv Provider Hub rau kev thov cov ntawv tso cai. Peb yuav muab ntaub ntawv ntxiv txog cov rooj cob qhia ntawd thaum peb npaj tau tiav.

Yam Koj Ua Tau Tam Sim No

Ntawm no yog qee yam uas koj ua kom npaj txhij rau kev siv lub Provider Hub:

- **Cuv Npe Txais ntawv xov xwm tshiab los ntawm Provider Hub:** Koj tuaj yeem [cuv npe txais tau cov ntawv xov xwm ntawm no](#).
- **Mus xyuas Provider Hub lub vev xaib:** Peb kho [Provider Hub](#) lub vev xaib thaum muaj cov cuab yeejtshiab tau npaj tiav los siv tau thiab thaum muaj cov ntaub ntawv qhia txog kev pab uas tuaj tshiab.
- **Tsim kev paub thiab nkag siab txog kev siv technology:** [Mus xyuas cov ntaub ntawv no uas muab kev pab rau kev siv technology](#). Nws muaj cov ntaub ntawv qhia txog cov txuj ci technology uas yuav tsum paub kom siv tau lub Provider Hub, ib daim ntawv soj ntsuam koj tus kheej txog koj cov txuj ci siv technology, thiab ib daim ntawv teev cov kev pab kom nkag tau thiab siv technology tau yooj yim.

QhovZoo Ntawm Kev Siv Provider Hub

Peb zoo siab yuav muab cov txiaj ntsig no rau cov chaw zov menyuam uas siv Provider Hub:

- **Kev nkag tau siv yooj yim:** Saib thiab tswj xyuas koj daim ntawv tso cai thiab koj cov ntaub ntawv program hauv tib qho chaw. Koj nkag tau mus xyuas koj cov ntaub ntawv txhua lub sijhawm los ntawm txhua yam cuab yeej siv (device).
- **Kev khaws ntaub ntawv hauv online:** Koj khaws tau koj cov ntaub ntawv rau hauv cov cuab yeej no thiab tsuas hloov thaum twg muaj kev hloov tshiab xwb..
- **Kev pabcuam ntxiv:** Koj txais tau kev pab siv lub Provider Hub los ntawm pab pawg txhawb nyob ze koj cheeb tsam — hauv online thiab hauv xov tooj. Koj tseem yuav tau txais kev pab ntxivlos ntawm koj tus neeg muab daim ntawv tso cai thiab cov neeg ua hauj lwm hauv qhov program — lawduyav pom tau cov ntaub ntawv uas koj sau rau hauv Provider Hub.
- **Muaj Ntau Hom Lus:** Koj siv tau cov cuab yeej no uas hais lus Askiv, Hmoob, Somali, lossis lus Mev.
